- DTE Gas Company requests Michigan Public Service Commission's approval for issuance of a Certificate of Public Convenience and Necessity to Construct and Operate the West Van Born Pipeline and Facilities Project in Washtenaw County and Wayne County, Michigan.

The Michigan Public Service Commission (Commission) will hold a pre-hearing to consider DTE Gas Company's (DTE Gas) December 10, 2021 application requesting the Commission to: 1) determine that the West Van Born Pipeline Project serves the public convenience and necessity and is safe for operation based on the plans as proposed by DTE Gas; 2) grant DTE Gas a certificate of public convenience and necessity authorizing construction of approximately 7.0 miles of 24-inch diameter natural gas pipeline including associated metering, heating and regulation facilities, and station upgrades in Wayne and Washtenaw Counties including additional equipment at two (2) existing facilities and constructing two (2) new facilities: Willow Meter Station (Existing Willow Gate); Belleville Road Valve Site (New); Hannan Road Regulation Station (New); and Rouge Station (Existing); and 3) grant DTE Gas other relief.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to: mpscedockets@michigan.gov. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by February 9, 2022. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon DTE Gas Company's attorney, David S. Maquera, One Energy Plaza, Detroit, MI 48226.

The prehearing is scheduled to be held remotely by video conference or teleconference. Persons filing a petition to intervene will be advised of the process to participate in the hearing.

Any person wishing to participate without intervention under Mich Admin Code, R 792.10413 (Rule 413), or file a public comment, may do so by filing a written statement in this docket.
