Enclosed for filing is CenturyTel of Michigan, Inc. d/b/a CenturyLink's ("CenturyLink") Notice of Discontinuance in newspapers of general circulation, pursuant to Section 313(5)(a) of the Michigan Telecommunications Act, 1991 PA 1979, as amended, MCL 484.2313(5)(a).

In addition, CenturyLink would like to provide some clarification to the Notice of Discontinuance under Section 313(5) ("Notice") filed on February 16, 2022.

On page 1 of the Notice, the Notice states: "[t]his area is served by a competitor that provides fiber to the home." The Notice should have stated that the area is served by a competitor that offers hybrid fiber coaxial (HFC) cable.

Also, the Notice leaves the impression that there is only one voice service provider in Hope. CenturyLink would like to clarify that there are multiple wireless providers that offer service in the area.


