ORDER

Section 51 of Public Act 295 (Act 295) of 2008, MCL 460.1051, requires all providers of electric service to submit to the Commission an annual report that provides information relating to the actions taken by the electric provider to comply with the State of Michigan’s renewable energy standards. Pursuant to Section 51, the Commission directed each electric provider to file an annual report describing its compliance with the requirements of Public Act 295 annually, until further order of the Commission. Public Act 342 of 2016 repealed Section 51 in its entirety effective January 1, 2023. Recognizing that the repeal of Section 51 is effective as of January 1, 2023, the filing of annual reports is no longer required after that date. Member-regulated cooperatives, municipally owned utilities, and alternative electric suppliers (AESs) were required to file annual reports for the 2021 reporting period by June 30, 2022. These reports are the final statutorily required annual reports.

However, the Commission requests that each member-regulated cooperative, municipally owned utility, and AES¹ continue to provide annual reports on a voluntary basis in its assigned, above-captioned docket. Voluntary filing of renewable energy reports will assist the Commission Staff in tracking and monitoring the development of renewable energy in Michigan. The annual report template will continue to be updated every year and can be found on the Commission's website at <https://www.michigan.gov/mpsc/regulatory/electricity/renewable-energy/renewable-energy-filings>.

THEREFORE, IT IS ORDERED that member-regulated cooperatives, municipally owned utilities, and alternative electric suppliers serving retail customers may continue to voluntarily file annual reports regarding their actions to comply with Michigan's renewable energy standards in their renewable energy plan dockets by June 30 each year, as described in this order.

The Commission reserves jurisdiction and may issue further orders as necessary.

¹ AESs not serving retail customers were previously directed by the Commission to annually file a letter stating that they continue to not serve customers in lieu of filing an annual report. The Commission is no longer requesting this letter.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.

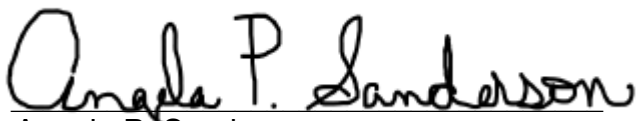
