**I. INTRODUCTION**

On February 10, 2023, DTE Electric Company (“DTE” or “DTE Electric”) filed, concurrently with its application in this proceeding, a proposed protective order to govern the disclosure of certain materials in the course of this case. On February 24, 2023, the Michigan Environmental Council, Natural Resources Defense Council, and the Citizens Utility Board of Michigan (collectively, “MNC”) filed objections (“Objections”) to DTE’s proposed protective order. On February 27, 2023, Attorney General Dana Nessel filed in support of MNC’s Objections to DTE’s proposed protective order.

**II. ARGUMENT**

Energy Michigan, Inc. (“Energy Michigan”) supports MNC’s Objections and hereby incorporates the four arguments stated in the Objections against adoption of DTE’s proposed protective order here as if fully stated herein.

**III. CONCLUSION AND PRAYER FOR RELIEF**

WHEREFORE, Energy Michigan respectfully requests that the Administrative Law Judge enter a protective order consistent with the recommendations originally stated in MNC's Objections.
