ORDER

On June 28, 2018, the Commission issued an order in Case Nos. U-20217 *et al.* (June 28 order) finding that the Commission will, going forward, assign case numbers for power supply cost recovery (PSCR), gas cost recovery (GCR), and steam supply cost recovery (SSCR) plan and reconciliation cases consistent with the Commission's E-Dockets filing system. Pursuant to the June 28 order, the Commission is assigning case numbers for 2026 and 2026-2027 PSCR, GCR, and SSCR plan and reconciliation cases.

THEREFORE, IT IS ORDERED that each electric, gas, and steam provider listed in the captions of this order is directed to file its applicable 2026 and 2026-2027 power supply cost recovery plan, gas cost recovery plan, steam supply cost recovery plan, power supply cost recovery reconciliation, gas cost recovery reconciliation, and steam supply cost recovery reconciliation in the case numbers provided in this order.

The Commission reserves jurisdiction and may issue further orders as necessary.

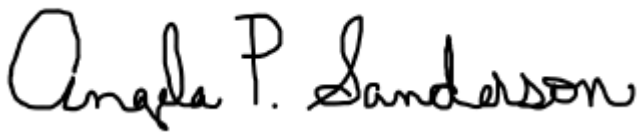
