

District 6 – Lake and Mason counties

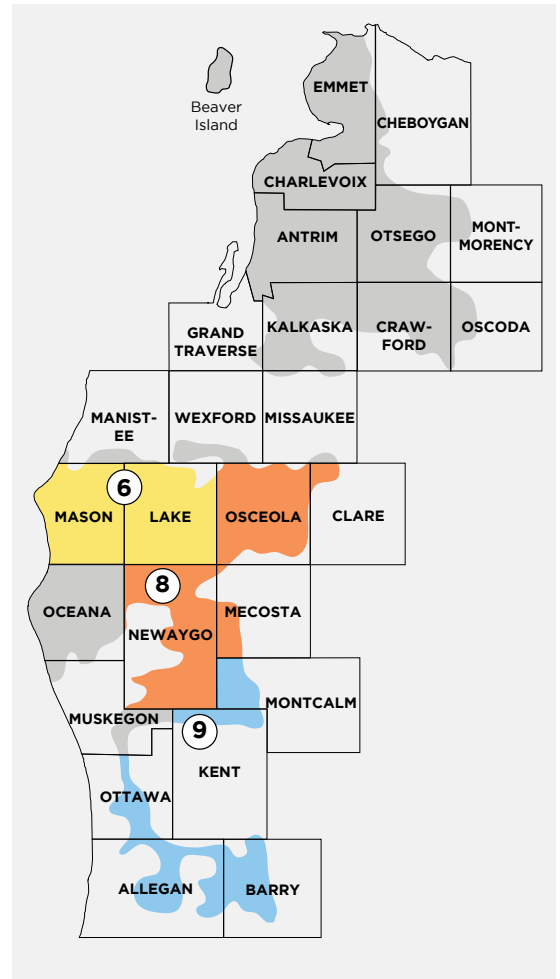
District 8 – Clare, Mecosta, Newaygo, and Osceola counties
