- This hearing is intended to provide information about the parameters of the Michigan Integrated Resource Planning Parameters (MIRPP) draft report, to receive public comment on the MIRPP draft report, and to answer questions about the MIRPP review process. - This notice of public hearing describes how a person may participate in this public hearing. The intent of this hearing is to inform the public about the Commission's own motion, to implement the provisions of Section 6t(1) of 2016 PA 341, the Commission's role, timeline, and the administrative process to be followed in [Case No. U-21867](#). The public hearing will be legislative in nature and any person may present data and views during the public comment period.

Public Comment for the Public Hearing:

Members of the public who wish to make a comment may do so during the public comment portion of the hearing, subject to the following requirements. Comments should be limited to no longer than three (3) minutes; however, the presiding officer will manage the public comment process and may adjust or place further limits on how long a person may speak.

Public comments must be directed to the Commission and should not be used to engage with other participants or respond to their comments. The public comment period is an opportunity for commissioners to listen to comments and concerns and not to answer questions. Public comments should be limited to one per person.
