On July 29, 2025, Bluebird MidWest, LLC, d/b/a Bluebird Fiber filed an application with the Michigan Public Service Commission (MPSC), as amended on September 25, 2025, for both a temporary and permanent license to provide basic local exchange service in the zone and exchange areas in which Michigan Bell Telephone Company, d/b/a AT&T Michigan, Frontier North, Inc., and Frontier Midstates, Inc. , are the incumbent local exchange carriers and in all other incumbent local exchange carrier service territories throughout the state of Michigan. This matter is set for an evidentiary hearing at **9:00 AM on Thursday, November 13, 2025 before the Michigan Public Service Commission, to be held by Video/Teleconference before Administrative Law Judge Katherine E. Talbot.**

Requests for adjournment must be made pursuant to the Michigan Office of Administrative Hearings and Rules System's Administrative Hearing Rules R 792.10422 and R 792.10432. Requests for further information on adjournment should be directed to (517) 284-8130.

Staff testimony, if any, shall be filed with the Commission on or before October 23, 2025. Rebuttal testimony shall be filed with the Commission on or before October 30, 2025. Interventions are due on or before November 6, 2025.

Bluebird MidWest, LLC, d/b/a Bluebird Fiber, shall publish a notice of hearing in accordance with 1991 PA 179, as amended. A copy of the notice of hearing and proofs of publication shall be filed with the Commission by the hearing on November 13, 2025.
