ORDER GRANTING PERMISSION FOR LAW STUDENT PARTICIPATION

On October 30, 2025, Mark N. Templeton, having been permitted to temporarily appear in this case, filed a Motion from Intervenor Urban Core Collective Under Michigan Administrative Code Section R. 792.10419 For Participation by a Law Student (“Motion”) for leave to have Ms. Jacqueline Hillman, a law student at the University of Chicago, participate in this proceeding to conduct focused cross examination of Consumers Energy Company’s witnesses. The Motion states that Ms. Hillman currently participates in the Abrams Environmental Law Clinic. Included with the Motion is a letter from the Assistant Dean of the University of Chicago Law School attesting to Ms. Hillman’s eligibility, a letter from Urban Core Collective (“UCC”) consenting to Ms. Hillman’s participation, and an affidavit from Ms. Hillman with the certifications set forth in MCR 8.120(C). The Motion states that Consumers and Staff do not oppose the Motion.

Based on those submissions and notice, and in accordance with Rule 419(3) and MCR 8.120(C), Jacqueline Hillman is permitted to participate in this case and conduct cross examination on behalf of UCC.


