The Michigan Public Service Commission (Commission) will hold a pre-hearing to consider Consumers Energy Company's (Consumers Energy) October 27, 2025 application requesting the Commission to amend the requirement for groundwater sampling in Paragraph 9 of the U-13322 Settlement Agreement approved by the Commission on October 3, 2002, to no longer require Consumers Energy to perform groundwater sampling; and grant Consumers Energy such other and further relief as is just and reasonable. Consumers Energy substantiates that the sampling that was required under Paragraph 9 of the Settlement Agreement has been performed and indicates that Lyon 29 does not negatively impact the local groundwater, and Consumers Energy is already subject to environmental requirements under any EGLE permits and applicable EGLE 3 regulations, therefore, the groundwater monitoring requirements under Paragraph 9 of the U-13322 Settlement Agreement are no longer necessary.

Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by November 27, 2025. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon Consumers Energy Company's Legal Department – Regulatory Group, 1 Energy Plaza Dr., Jackson, MI 49201.

The prehearing is scheduled to be held remotely by video conference or teleconference. Persons filing a petition to intervene will be advised of the process for participating in the hearing.

Any person wishing to appear at the hearing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of their wish to make a statement of position. Mich Admin Code, R 792.10413 (Rule 413).

Any person wishing to file a public comment may do so by filing a written statement in this docket. The written statement may be mailed or emailed and should reference Case No. **U-13322**.
