ORDER

On May 29, 2026, Walker Road Solar Farm LLC (Walker Road) submitted an application in this docket, with supporting testimony and exhibits, seeking a certificate for the construction of a 150-megawatt solar energy facility in Bingham Township, Clinton County, Michigan, pursuant to Public Act 233 of 2023, MCL 460.1221 *et seq.*

On June 1, 2026, Administrative Law Judge Lelsey C. Fairrow scheduled a prehearing for this matter to take place on July 27, 2026.

On July 14, 2026, Walker Road filed a notice of withdrawal of application in this docket requesting that the Commission authorize the withdrawal of its application. The notice also provided that no notices or publications related to the previously scheduled prehearing had been published or mailed.

The Commission finds that Walker Road's request to withdraw its application is reasonable and should be granted.

THEREFORE, IT IS ORDERED that Walker Road Solar Farm LLC's request to withdraw its application is granted, and the docket in this proceeding is closed.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.

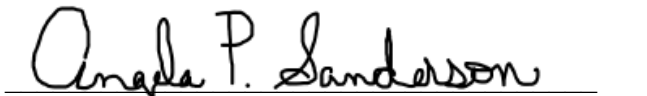
