### **ORDER**

In each of the above separately captioned proceedings, the Commission granted the named  
 applicant a license to provide basic local exchange service in Michigan pursuant to the licensing  
 provisions set forth in the Michigan Telecommunications Act, 1991 PA 179, MCL 484.2101 *et*

seq.<sup>1</sup> Acquisition of a license to provide basic local exchange service carries with it certain responsibilities, including, but not limited to, the duty to “comply with all federal and state requirements regarding truth in billing, E 9-1-1 services, and primary basic local exchange service.” MCL 484.2305b(c). Moreover, providers of basic local exchange service are obligated to obey the lawful orders of the Commission and to respond promptly to reasonable requests from the Commission Staff (Staff).

It has been brought to the Commission’s attention that the providers listed in the case captions of this proceeding have been grossly deficient in attending to the statutory and regulatory responsibilities of licensed basic local exchange service providers.

MCL 484.2205 authorizes the Commission to revoke a provider’s license to provide basic local exchange service. In Michigan, a formal action to revoke a license must be preceded by an informal notice to the licensee of the intended action and an opportunity for the licensee “to show compliance with all lawful requirements for retention of the license.” MCL 24.292; *Rogers v Cosmetology Board*, 68 Mich App 751; 244 NW2d 20 (1976).

On May 21, 2009, Robin Ancona, Director of the Commission’s Telecommunications Division, sent a letter to each of these 30 licensees. The licensees were advised that the purpose of the May 21, 2009 letter was to ascertain “whether your company wishes to retain [its] license” to provide basic local exchange service in Michigan. In each letter, the licensee was notified of past unsuccessful attempts by the Staff to contact the licensee by regular mail, telephone, and e-mail. The letters informed these providers to “respond to this inquiry no later than 45 days from the date of this letter and indicate if the company intends to retain its license and is providing service, or has ceased operations.” Finally, each letter notified the licensee that “[i]f no response is received,

the Commission will take the necessary steps to commence the process of revoking [its] license.” To date, none of the 30 providers have responded to Ms. Ancona’s letter. At best, the Staff received email contacts in which the company did not object to its license being revoked, but declined to take the minimal steps necessary to surrender its license.

The Commission finds that the preliminary steps for license revocations required in MCL 24.292 and *Rogers v Cosmetology Board*, supra, have been completed and that the Commission may now commence formal proceedings to revoke the licenses of the providers listed in the captions of this proceeding. Therefore, the Commission orders each provider listed in the captions of this proceeding that desires to retain its license to provide basic local exchange service to file an intervention in Case No. U-16072 by September 24, 2009 and to appear at the October 15, 2009 joint hearing before Administrative Law Judge Daniel E. Nickerson, Jr., (ALJ) that will take place at 9:00 a.m. in the Commission’s Lansing offices, 6545 Mercantile Way, Lansing, Michigan 48911. The Staff shall also attend the October 15, 2009 hearing.

If a provider does not intervene in the proceeding and/or fails to attend the October 15, 2009 hearing, the ALJ shall, after receipt of testimony and exhibits from the Staff, render a Proposal for Decision (PFD) with regard to the issue of whether that provider’s license to provide basic local exchange service should be revoked immediately by the Commission. For any provider that intervenes in the proceeding and attends the hearing, the ALJ shall treat the hearing as a prehearing conference in a separate complaint case brought in the docket for the provider’s license, unless the provider agrees to voluntarily relinquish its license or the Staff requests dismissal of further proceedings against the provider.

If the provider requires assistance prior to e-filing, contact Commission staff at (517) 241-6170 or by e-mail at [mpscedockets@michigan.gov](mailto:mpscedockets@michigan.gov). All information received by the Commission will become public information, posted on the Commission's website, and subject to disclosure.

THEREFORE, IT IS ORDERED that each of the following providers: ACCXX Communications, LLC, ARBROS Licensing Company Central, LLC, Atlas Communications, LTD., Building Communications, Inc., d/b/a BCI, CAT Communications International, Inc., CCCMI, Inc., d/b/a Connect!, CI<sup>2</sup> Inc., d/b/a Computer Intelligence<sup>2</sup> Inc., Cypress Telecommunications Corporation, d/b/a Cytel, Globetel, Inc., Group Long Distance, Inc., Horizon Telecommunications, Inc., d/b/a Voyager Telecommunications, Computer Business Sciences, Inc., IPVoice Communications, Inc., Mabel Communications, Inc., Metro Teleconnect Companies, Inc., MichTel Inc., NationsLine Michigan, Inc., Essex Communications, Inc., d/b/a eLEC Communications, NTERA, Inc., OneStar Long Distance, Inc., Pacific Centrex Services, Inc., Phone Express Michigan Inc., Premiere Network Services, Inc., Quality Telephone Inc., Suretel, Inc., Telera Communications, Inc., Truly Clear Communications Inc., Vota Telephone LLC, d/b/a Votatel, Winstar Wireless of Michigan, Inc., and Ygnition Networks, Inc., that desires to retain its license to provide basic local exchange service in Michigan shall intervene in Case No. U-16072 no later than September 24, 2009, and appear at the hearing before Administrative Law Judge Daniel E. Nickerson, Jr., in the Commission's offices at 6545 Mercantile Way, Lansing, Michigan on October 15, 2009 at 9:00 a.m.

The Commission reserves jurisdiction and may issue further orders as necessary.
