



The Michigan Public Service Commission (Commission) will hold a public hearing to consider Consumers Energy Company's (Consumers) March 30, 2001 application to recover about \$25 million from its customers for implementation costs incurred from January 1, 2000 through December 31, 2000 for its customer choice (also known as open access or direct access) program. This program is designed to allow customers the option to choose suppliers other than Consumers for their electricity source. Consumers' application states that implementation costs for 2000 were about \$25 million. Consumers proposes to recover this amount through a surcharge that will be implemented at the expiration of the statutory rate freeze/rate cap period. Customers will see no impact on their bills at this time.

The Commission has selected this case for participation in its Electronic Filings Pilot. Therefore, all filings in this case, including petitions to intervene, shall be made by both paper submission and electronic format.
