The Michigan Public Service Commission (Commission) will hold a public hearing to consider Aquila Networks–MGU’s (Aquila) August 2, 2002 application for authority to increase its rates for the transportation and distribution of natural gas by approximately \$14,283,246 annually. Aquila also filed a motion for partial and immediate rate relief of not less than \$9,281,000 annually, submitted a number of specific proposals concerning cost recovery for investigation and remediation associated with former manufactured gas plant sites and revisions to the existing transportation rate structure. Aquila also proposes to increase the monthly customer charge for residential customers from \$7.25 to \$8.00. A comparison of the present and proposed rates follows:
