Dear Ms. Kunkle:

Wolverine Power Supply Cooperative, Inc. ("Wolverine") filed two documents in this case dated February 11, 2005 -- one its Reply Comments and the other a single page letter filed on February 15. Both documents indicate that Wolverine intends to file by February 25, 2005 "additional power flow studies and other data in support of its position," as invited by Commission Staff. (Letter.) Wolverine also indicated that it wished to meet with Commission Staff and "try to reach a settlement of concerns raised by staff." (Reply Comments, page 30)

Consumers does not object to Wolverine presenting additional data and study results, as long as Consumers has an opportunity to respond to any such new material presented by Wolverine. Consumers is also interested in presenting additional study results of its own, along the lines suggested by Commission Staff. (Of course, Consumers would have no objection to Wolverine responding to any such new material it may present.) Consumers would also like to take part in any meetings held to resolve this proceeding.
