

- Michigan Consolidated Gas Company may increase its annual natural gas distribution revenues by a total of at least \$193,632,000, if the Michigan Public Service Commission approves its request.
- **BASED ON THE \$193,632,000 REQUEST, A TYPICAL RESIDENTIAL CUSTOMER'S AVERAGE NATURAL GAS DISTRIBUTION BILL MAY INCREASE BY ABOUT \$10.00 PER MONTH.**

The Michigan Public Service Commission (Commission) will hold a public hearing to consider the September 30, 2003 application of Michigan Consolidated Gas Company (Mich Con) to amend its natural gas distribution rates to increase its gas distribution revenues in the annual amount of \$193,632,000. Mich Con has requested that \$153,739,000 of this increase be approved on an immediate basis, subject to refund after the entire case is concluded.

Mich Con has also submitted a number of specific proposals concerning the need for additional revenues to pay for the impact of increased costs associated with providing employee and retiree pension and health care benefits; the increased costs associated with the physical security of its natural gas pipeline system; increased costs of company use and lost gas reduced revenues due to significant declines in consumption related to more efficient natural gas equipment; reduction in end-use transportation; and recovery of operation and maintenance and

capital expenditures necessary to maintain safe reliable operation of Mich Con's distribution system, and recovery costs to remediate former manufactured gas plant sites.

Mich Con also proposes to increase the monthly customer charge for residential customers from \$7.50 to \$11.50 per month.

The Commission has selected this case for participation in its Electronic Filings Program. The Commission recognizes that some residential customers may not have the computer equipment or access to the Internet necessary to submit documents electronically. Therefore, residential customers may submit documents in the traditional paper format and mail them to the: Executive Secretary, Michigan Public Service Commission, 6545 Mercantile Way, P.O. (Residential customers may file petitions to intervene using the traditional paper format.) The proof of service shall indicate service upon Mich Con's attorney, Bruce R. Any person wishing to make a statement of position without becoming a party to a case may participate by filing an appearance. To file the appearance, the individual must attend the

hearing and advise the presiding administrative law judge of his or her wish to make a statement of position.
