The Michigan Public Service Commission (Commission) will hold a public hearing to consider the February 12, 2004 application of Consumers Energy Company (Consumers) for a certificate of public convenience and necessity to construct and operate the West Oakland

Pipeline, a 24.4 mile long, 36-inch diameter gas transmission pipeline in Oakland County. The pipeline will extend in an easterly direction from Clarkston Junction in Section 28, Rose Township to a point of interconnection with the Oakland Pipeline in Section 30, Oakland Township.

The Commission has selected this case for participation in its Electronic Filings Program.
