NOTICE OF IMPLEMENTATION OF ETHICAL SCREENING WALL

2. Mr. Nelson will not participate in this litigation;
3. All lawyers and employees of the Fraser firm have been instructed not to discuss the pending litigation with Mr. Nelson, or in his presence, or provide him with access to any documents or other materials relating to this litigation, or receive any information from Mr. Nelson regarding this litigation;
4. The files concerning this litigation have been segregated and marked so that Mr. Nelson does not inadvertently view the contents of the file;
5. Mr. Nelson will not be paid from any portion of the fees paid to Fraser

Trebilcock Davis & Dunlap, P.C., on the file; and

6. The firm and Mr. Nelson have agreed to abide by the above restrictions.

The above screening procedures will remain in place until the pending matter is completed in its entirety.
