- Michigan Consolidated Gas Company and other natural gas affiliates will replace their existing Mcf unit with an MMBtu unit for purposes of nominating and tracking gas transportation and storage services on its systems, if the Michigan Public Service commission approves its request.
- **THE PROPOSED CONVERSION WILL NOT CHANGE THE EFFECTIVE RATES OR COSTS UNDERLYING THE CURRENT RATES OF ANY OF ITS CUSTOMERS.**

The Michigan Public Service Commission (Commission) will hold a public hearing to consider the April 13, 2004 application of Michigan Consolidated Gas Company (Mich Con), Mich Con Gathering, Thunder Bay Pipeline Co., Westside Pipeline Co., Saginaw Bay Pipeline Co., Mich Con Lateral Co., Saginaw Bay Lateral Co., and Jordan Valley LP (affiliates) to convert gas nominating and gas storage balance operations from an Mcf to an MMBtu basis. Mich Con states that the conversion will simplify its business relationships, increase administrative efficiencies, and that no additional charges or increased costs will be passed on to third parties operating on Mich Con's system. Mich Con states that approval of the application will not affect Mich Con's metering or billing practices associated with its bundled sales, end use transportation (EUT) customers, or gas choice customers and the company will continue to charge these customers based on actual or estimated usage measured in Ccf units.

Mich Con proposes to use a one-time system-wide Btu conversion factor to convert storage balances as of the last day of the month immediately preceding the first calendar day of the implementation month. This one-time system-wide Btu conversion factor will be based on the average of the most recent 12 months computed as: the heating value of all gas flowing into Mich Con's distribution system, plus the heating value of Mich Con gas storage field withdrawals or minus the heating value of Mich Con gas storage field injections, less the heating value of off-system deliveries. A monthly system-wide Btu factor will be computed in this manner each month, to convert Ccf metered consumption to therms in order to determine end of month storage balances for end use transportation (EUT) customers.

In the event that the Commission does not issue its final order approving this application by September 16, 2004, Mich Con proposes to delay implementation until April 1, 2005. Additionally, Mich Con proposes to implement this conversion at the beginning of the first month that starts at least two weeks after issuance of the Commission's order.

The Commission has selected this case for participation in its Electronic Filings Program. The Commission recognizes that all filers may not have the computer equipment or access to the Internet necessary to submit documents electronically.
