**ORDER**

On June 21, 2004, Cliff Hart & Associates, Inc., and Attorney General Michael A. Cox filed complaints against Alliance Group/National Access Long Distance alleging violations of the Michigan Telecommunications Act, MCL 484.2101 et seq. On August 11, 2004, the complainants filed requests to dismiss the complaints with prejudice.

The Commission FINDS that:

a. Jurisdiction is pursuant to 1991 PA 179, as amended, MCL 484.2101 et seq.; 1969 PA 306, as amended, MCL 24.201 et seq.; and the Commission's Rules of Practice and Procedure, as amended, 1999 AC, R 460.17101 et seq.

b. The complaints should be dismissed with prejudice.

THEREFORE, IT IS ORDERED that the complaints of Cliff Hart & Associates, Inc., and Attorney General Michael A. Cox against Alliance Group/National Access Long Distance are dismissed with prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.
