ORDER

On February 28, 2005, WPS Energy Services, Inc. (WPS), applied for a license to operate as an alternative gas supplier (AGS) within Michigan pursuant to 2002 PA 634, MCL 460.9 *et seq.* On June 30, 2005, the Commission approved WPS's license. On March 15, 2007, WPS informed the Commission of its name change to Integrys Energy Services, Inc. (Integrys).

On January 23, 2014, Integrys requested the voluntary relinquishment of its license. The company has assigned all its customers to Integrys Energy Services-Natural Gas, LLC,¹ and so is no longer serving customers in the state of Michigan. The Commission Staff recommends approval of this request, noting that there are no customers adversely affected by the rescission.

¹ Integrys Energy Services-Natural Gas, LLC, an affiliate of Integrys Energy Group, Inc., was granted an AGS license in the April 13, 2010 order in Case No. U-16187.

The Commission finds that the request for voluntary relinquishment of Integrys Energy Services' AGS license should be approved. Further, the Commission finds that this docket should be closed.

THEREFORE, IT IS ORDERED that Integrys Energy Services, Inc.'s license as an alternative gas supplier in the state of Michigan is rescinded and this docket is closed.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days issuance and notice of this order, pursuant to MCL 462.26.


