The Michigan Public Service Commission (Commission) will hold a public hearing to consider the January 25, 2007 application of Washington 10 Storage Corporation, which seeks approval for a certificate of public convenience and necessity to construct and operate the Washington 10-28 natural gas pipeline in Washington Township, Macomb County, Michigan. The proposed pipeline will interconnect Washington 10 Storage Corporation (W10) compressor station to South Romeo Gas Storage Company (SRGS) at the Washington 28 (28) storage field station, and will be constructed parallel to and or within existing electric transmission line and high pressure transmission pipeline right of way or easements for a majority of its length.

Any person wishing to make a statement of position without becoming a party to the case, may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's Web site, and subject to disclosure.
