Osirus will have the burden of proving that it possesses sufficient technical, financial, and managerial resources and abilities to provide basic local exchange service to any prospective customer within the requested geographic areas, and that granting of the requested license will not be contrary to the public interest. The MPSC has jurisdiction pursuant to 1991 PA 179, as amended, MCL 484.2101 *et seq.*; 1969 PA 306, as amended, MCL 24.201 *et seq.*; and the Commission's Rules of Practice and Procedure, 2000 AC, R 460.17101 *et seq.*
