

The Michigan Public Service Commission (Commission) will hold a public hearing to consider the June 30, 2009 application of Detroit Thermal, LLC (Detroit Thermal), which seeks approval of its steam cost recovery reconciliation proceeding for the twelve-month period beginning April 1, 2008 through March 31, 2009. Detroit Thermal is requesting that the Commission authorize the company to roll-in the net underrecovery of \$751,331, including interest into its 2009-2010 plan period.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets Website at: michigan.gov/mpscedockets. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by September 10, 2009. Peck, Fischer, Franklin & Ford, Guardian Building, Suite 3500, 500 Griswold Street, Detroit, MI 48226-3808.

Any person wishing to make a statement of position without becoming a party to the case, may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's Web site, and subject to disclosure.
