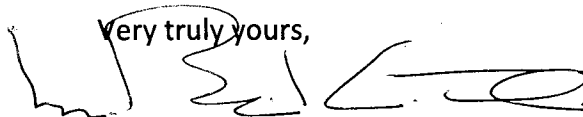

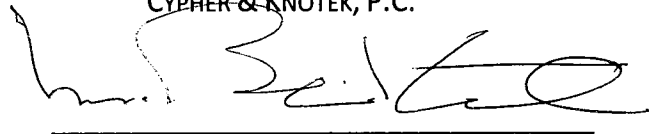
STATEMENT OF NON-OBJECTION

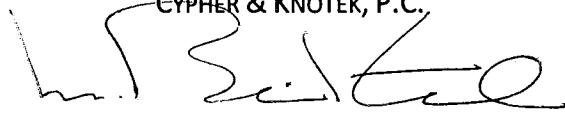
