- The Michigan Public Service Commission will be conducting regulatory reviews, revisions, determinations and/or approvals necessary for Consumers Energy Company to fully comply with certain provisions of Public Act 295 of 2008.
- The rates, terms and conditions associated with the implementation of renewable energy and energy optimization plans, among other issues, will be considered in Case Nos. U-15805 and U-15889, which will be conducted on a consolidated basis.

The Michigan Public Service Commission (Commission) will hold a public hearing to consider Consumers Energy Company's (Consumers Energy) application to be filed by February 18, 2009, seeking approval of its Renewable Energy Plan and its Energy Optimization Plan.

Consumers Energy seeks approval of a Renewable Energy Plan, which is a 20 year plan for achieving compliance with the provisions of 2008 PA 295. The plan includes estimates of the amount of renewable energy that Consumers Energy needs to obtain in order to meet the renewable energy standards established by that act, a description of the manner in which the Company intends to acquire that renewable energy, and estimates of the costs of doing so. The annual levelized revenue increase associated with the incremental cost of the proposed Renewable Energy Plan for the 20-year period of the plan is approximately \$88 million. The Company seeks approval of Renewable Energy surcharges to recover these costs in the following amounts:

Consumers Energy also seeks approval of an Energy Optimization Plan, which is a plan for achieving compliance with the energy optimization provisions of 2008 PA 295. The plan includes descriptions of the programs that Consumers Energy intends to implement to meet the energy optimization standards established by the act, as well as the estimated cost of those programs. The total cost of the electric Energy Optimization Plan proposed by Consumers Energy over the initial 6-year period of the plan is approximately \$300 million. The Company seeks approval of Energy Optimization surcharges to recover these cost from electric customers in the following amounts:
