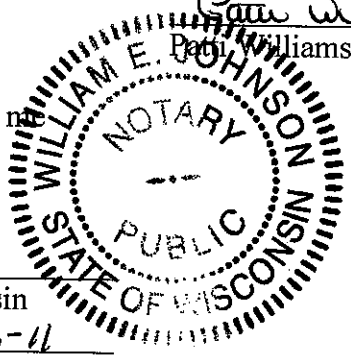

NOTICE OF OPPORTUNITY TO COMMENT

On December 4, 2008, the Michigan Public Service Commission (Commission) ordered Bayfield Electric Cooperative, Inc. to file a renewable energy plan on or before April 3, 2009, to comply with the "Clean, Renewable, and Efficient Energy Act" (2008 PA 295, MCL § 460.1001 et seq.) in Case No. U-15800.

Written and electronic comments may be filed with the Commission and must be received no later than 5:00 p.m. on May 4, 2009. [mpscedockets@michigan.gov](mailto:mpscedockets@michigan.gov) . All documents should reference case No. U-15814. Comments received in this matter will become public information, posted on the Commission's website, and subject to disclosure.

The Commission will review the Renewable Energy Plan together with any filed comments and provide a response by June 3, 2009, indicating any revisions that should be made. If the Commission suggests revisions, Bayfield Electric Cooperative, Inc. will file a revised Renewable Energy Plan on or before June 18, 2009. A Commission order will issue on or before July 6, 2009.

Any proposed Renewable Energy Plan charges may not exceed \$3 per meter per month for residential customers, \$16.58 per meter per month for commercial secondary customers or \$187.50 per meter per month for commercial primary or industrial customers.
