Reference is made to your letter dated April 21st, 2010, citing the failure of Startec Global Operating Company to submit a response to a request of the Michigan Public Service Commission in the above-referenced case.

Please note that Startec Global Operating Company was merged into Americatel Corporation effective April 30, 2009. As part of the merger, Americatel notified the Commission of the impending merger. After the merger we notified the Commission of the consummation of the merger by a letter dated May 1, 2009 and again notified the Commission that Startec was withdrawing from the provision of interexchange services in Michigan by letter dated May 20, 2009. 

Americatel Corporation ("Americatel") and Startec Global Operating Company ("Startec") hereby notify the Commission that the *pro forma* internal corporate restructuring that the companies made before the Michigan Public Service Commission has been finalized and Startec has officially merged into Americatel.

Based upon the completion of the *pro forma* internal corporate restructuring all future revenues will be reported on the Americatel reports. Startec will no longer file any reports with the Commission, including any 2009 annual reports due in 2010. All revenue realized by Startec in first 4 months of 2009 will be reported as Americatel revenue for any 2009 summary reports filed by Americatel.
