- International Transmission Company, d/b/a ITC*Transmission* will construct an overhead transmission line running from the south west side of Michigan's Thumb region in Tuscola County to the north-central area of the Thumb in Huron County, then running south through Sanilac County, and ending in St. Clair County, if the Michigan Public Service Commission grants ITC*Transmission* an expedited siting certificate for the transmission line. The proposed transmission line will run through the following townships: Tuscola, Denmark, Gilford, Fairgrove, Akron, Columbia, Sebewaing, Brookfield, Winsor, Oliver, Colfax, Verona, Sigel, Paris, Minden, Wheatland, Custer, Sandusky, Watertown, Washington, Buel, Fremont, Greenwood, Kenockee, Wales, and Columbus. The proposed transmission line will also run through a portion of the City of Sandusky. The Michigan Public Service Commission (Commission) will hold a public hearing to consider the August 30, 2010 application of International Transmission Company, d/b/a *ITCTransmission*, for an expedited siting certificate to construct a transmission line in order to facilitate the transmission of electricity generated by wind energy conversion systems located in the primary wind energy resource zone No. 4, as designated by the Michigan Public Service Commission in its January 27, 2010 Order in Case No. U-15899. *ITCTransmission* proposes to construct the transmission line from the south west side of Michigan's Thumb region in Tuscola County to the north-central area of the Thumb in Huron County, then running south through Sanilac County and ending in St. Clair County. The proposed transmission line will run through the following townships: Tuscola, Denmark, Gilford, Fairgrove, Akron, Columbia, Sebewaing, Brookfield, Winsor, Oliver, Colfax, Verona, Sigel, Paris, Minden, Wheatland, Custer, Sandusky, Watertown, Washington, Buel, Fremont, Greenwood, Kenockee, Wales, and Columbus. The proposed transmission line will also run through a portion of the City of Sandusky. An alternate transmission line has been included in the application, which may be viewed on the Commission's website at: michigan.gov/mpscdockets.

All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's website, and subject to disclosure.
