MetTel’s services will be available to any person seeking a basic local exchange service provider in MetTel’s service areas. MetTel will have the burden of proving that it possesses sufficient technical, ~~financial, and managerial resources and abilities to provide basic local exchange service to any~~ prospective customer within its service areas, and that granting of the requested license will not be contrary to the public interest.


