The Michigan Public Service Commission (Commission) will hold a public hearing to consider the August 24, 2011 application of Michigan Consolidated Gas Company's (MichCon), as amended on September 7, 2011, and revised on February 2, 2012, which seeks Commission's

approval to bring the self-implemented rate amounts in line with the Commission's January 20, 2011 Order in Case No U-16447 in the amount of \$25,756,595 by surcharging customers for over-refunded amount by rate class.
