

Further, Affiant sayeth not.

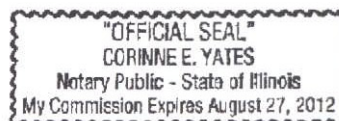


