

We respectfully Petition To Intervene in the above referenced case with cause based on a defect in the Proof Of Service Notice dated September 19, 2011 by Michael S. Ashton (attached). We were never properly served in this matter. The Poof Of Service indicates that Alice McNaughton, PO Box 688, Birmingham, MI 48012 was served. However, she was a prior owner of the property and has been deceased for several years. We purchased the property from Mrs. McNaughton's heirs in 2010. Despite our ownership of the property being a matter of public record since well before these proceedings were commenced, we were never properly served by Enbridge, and learned of their Petition only by chance while recently researching a neighboring piece of property.

Please accept this letter to enter this case with cause. We also wish to make you aware we are in the process of retaining Legal Counsel to represent us in this matter. However, we wanted to file this on our own behalf as soon as we were aware of the defect in the Service. Since we have been denied our rights by the defect in the proof of service, we felt compelled to initiate this formal request to protect our rights.


