

Dear PSAP Coordinator;

Boomerang Wireless, LLC d/b/a enTouch Wireless (“enTouch”) has been authorized by the Department of Licensing and Regulatory Affairs to offer Lifeline service in the state of Michigan. As enTouch is using the Sprint and Verizon networks to provide Lifeline service, Sprint and Verizon will continue to provide 9-1-1 services for our enTouch customers.

Lifeline provides affordable phone service for more than 7 million low-income Americans. enTouch provides free services to Lifeline eligible customers. Presently, only about one-third of the Lifeline eligible households subscribe to the program. enTouch is pleased to be one of the companies to offer Lifeline in your state. The Department has requested that enTouch confirm with all Public Safety Answering Points (“PSAPs”) in enTouch’s designated service area that 911/E911 access will be available to Lifeline customers regardless of activation status and availability of prepaid minutes.

Please keep in mind that enTouch provides prepaid wireless telecommunications services to customers using the Sprint PCS network. Sprint Nextel is a nationwide facilities-based carrier that provides wholesale capacity to resellers such as enTouch. All enTouch 911/E911 calls are routed by Sprint to the appropriate PSAP, the same way that Sprint routes its own 911/E911 calls. Attached is a copy of the letter from Sprint confirming it will continue to route 911/E911 calls in its coverage area and provide the necessary updates to the PSAPs.

enTouch also utilizes the services of Verizon Wireless in the same way. We have requested a confirmation letter from Verizon and will update this filing by providing you a copy of that letter when received. enTouch has several Lifeline plans available to eligible consumers in Michigan. The first is a 125 Free Monthly Minute Plan. This plan offers 125 units per month for voice and text. Lifeline free minutes are automatically posted each month on the Lifeline customer’s service date.



Rollover units continue to rollover for one (1) month, and if unused will expire on the monthly service date two (2) months from the date upon which initially credited to the Subscriber. Rollover units do not transfer if the customer changes calling plans.

The Company also provides a 250 Free Monthly Minute Lifeline Plan: This plan offers 250 units per month for voice and text. Lifeline free minutes are automatically posted each month on the Lifeline customer's service date. There is no roll over of minutes with this plan.

For those eligible consumers in Michigan who live on tribal land, the Company offers a 1000 Plus Bundle Plan. This plan offers 1000 units per month for voice and text. Lifeline free minutes are automatically posted each month on the Lifeline customer's service date. Tribal plan only available to eligible customers who reside on Federal recognized Tribal lands. There is no roll over of minutes.

enTouch provides a free handset (usually a refurbished device) and 10 MB of Data (website and email). enTouch's features available with all Lifeline Plan offerings include a Local calling, Domestic/National Long Distance calling, Caller ID, Call Waiting, Call Forwarding, 3-way Calling and Voice Mail. Also, there is free 411 (there are no charges, however applicable unit(s) are decremented); and 9-1-1 Emergency Service and 611 enTouch Customer Service is available regardless of units/minutes available within the month.

Thank you for your assistance in enabling enTouch Wireless to offer Lifeline to low-income households in your area.

Dear Mr. Henderson:

As requested by Boomerang, this letter sets forth details regarding Sprint’s routing of E911 (as defined below) calls from Boomerang’s End Users (as defined in the Agreement), including End Users of Boomerang’s Resellers (as defined in the Agreement). As set forth in the Agreement, Sprint provides wireless services to Boomerang on Sprint’s network and Boomerang resells such wireless services to its End Users and Resellers under Boomerang’s brand (“**Private Label Service**”).

Sprint currently routes 911 calls from customers to the Public Safety Answering Points (“**PSAPs**”) in each state. Boomerang’s End Users that receive the Private Label Service will have access to 911 and enhanced 911 (“**E911**”) service. In this regard, Sprint hereby confirms that it routes 911 and E911 calls from Boomerang’s End Users utilizing the Private Label Service to PSAPs in the same manner as Sprint routes 911 and E911 calls from its own customers.

In accordance with the applicable Federal Communications Commission (“**FCC**”) requirements, Sprint has engaged in 911 testing with PSAPs to confirm access to 911 and E911 service. Thus, as a wholesale customer of Sprint, Boomerang’s End Users utilizing the Private Label Service will have the same access to 911 and E911 service as Sprint’s own customers.
