- Michigan Electric Transmission Company, LLC requests Michigan Public Service Commission's authority for a certificate of public convenience and necessity to construct two double-circuit 138 kilovolt (kV) transmission lines on a 220-foot right-of-way running through Oshtemo Township, Kalamazoo County, Michigan and an electrical transmission substation in Almena Township, Van Buren County, Michigan.

The Michigan Public Service Commission (Commission) will hold a public hearing to consider Michigan Electric Transmission Company, LLC's, (METC) July 31, 2012 application for a certificate of public convenience and necessity to construct two double-circuit 138 kilovolt (kV) transmission lines on a 220-foot right-of-way running through Oshtemo Township, Kalamazoo County, Michigan and an electrical transmission substation in Almena Township, Van Buren County, Michigan.
