Dear Sir or Madam:

On October 7, 2015, the Commission issued an order in Case No. U-17585, initiating an inquiry into gas service lines connected directly to gas storage fields, transmission pipelines, regulated and unregulated gathering lines, oil and gas wells, and gas processing facilities that are serving residential or commercial gas consumers. Shortly after the order was issued, the Commission served the order and attachment on CompanyName. The order, included with this letter, required that, "All providers shall respond to this request for information by December 1, 2015. Providers that do not have connections as described in the order shall respond with a letter so indicating."

Our records indicate that, to date, the Commission has not received a response from CompanyName. We request that you respond to the directives in the enclosed order within 45 days of the date of this letter. Responses should be sent to: Michigan Public Service Commission, Gas Operations Section, 7109 W. Saginaw Hwy., Lansing, MI 48917.
