- Detroit Thermal, LLC requests Michigan Public Service Commission approval to implement a maximum base Steam Supply Cost Recovery (SSCR) plan and factor of \$13.91 per thousand pounds of steam (Mlb) for the 12-month period beginning April 1, 2015 through March 31, 2016.

The Michigan Public Service Commission (Commission) will hold a public hearing to consider Detroit Thermal, LLC's (Detroit Thermal) December 30, 2014 application for approval of a proposed SSCR plan and factor of \$13.91 per Mlb for the 12-month period from April 1, 2015 through March 31, 2016, with the option for quarterly increases determined by the Quarterly SSCR Factor Price Adjustment (Contingency) Mechanism for the remainder of the twelve-months ending March 31, 2016. Detroit Thermal is also requesting the Commission to: 1) approve the Company's Incremental Contingent SSCR Factors for the April 1, 2015 through March 31, 2016 period; and 2) find its three-year forecast is reasonable and prudent.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscdockets. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by February 12, 2015. Any person wishing to appear at the hearing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter becomes public information, thus available on the Michigan Public Service Commission's website, and subject to disclosure. Please do not include information you wish to remain private.
