Sprint Communications Company L.P. (“Sprint”) hereby notifies all interested parties that, effective on September 19, 2015, it will discontinue the provision of Sprint Wireline consumer long distance toll service. The specific services to be discontinued are known as Sprint Message Telecommunications Service (*i.e.*, 1+ long distance) (“MTS”), FÖNCARD, Directory Assistance, and Operator Service (collectively, the “Sprint Services”). Affected Customers have been notified via First Class US Mail letters.

A person or telecommunications provider affected by this discontinuance can submit comments to the Michigan Public Service Commission (“Commission”) within 60 days after publication of this notice to determine if the discontinuance is authorized pursuant to the Michigan Telecommunications Act. Comments may be filed by US Mail or by E-mail. Comments filed by U.S. Mail should be sent to Executive Secretary, Michigan Public Service Commission, P.O. Box 30221, Lansing, MI 48909. Comments filed by E-Mail may be submitted to the Commission at <mpscefilecases@michigan.gov>. All comments should reference Case No. U-17865. Please note that all filed comment become public record.
