The Michigan Public Service Commission (Commission) will hold a public hearing to consider Detroit Thermal LLC's (Detroit Thermal) December 28, 2017 application which requests the following: 1) approval of its Steam Supply Cost Recovery Plan and Factors for the 12-month period from April 1, 2018 through March 31, 2019; 2) authorization for Detroit Thermal to charge up to the proposed base SSCR Factor of \$13.44 per Mlb. with the option for quarterly increases determined by the Quarterly SSCR Factor Price Adjustment (Contingency) Mechanism for the remainder of the twelve-months ending March 31, 2019; 3) approval of the Incremental Contingent SSCR Factors for the April 1, 2018 through March 31, 2019 period; 4) to review Detroit Thermal's plans and projections through March 2021, finding that the three-year forecast is reasonable and prudent, and indicate any cost items that cannot be recovered; and 5) other and additional relief.
