ORDER

On January 28, 1992, the Commission issued an order to effectuate Act 179, the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, directing all telecommunications providers of basic local exchange service to file a copy of their license authorizing the carrier to provide basic local exchange service in this state, or if one did not exist, the provider should indicate such. On August 14, 1992, the Commission issued new licenses to providers of basic local exchange service as of January 1, 1992. On November 8, 2011, Blanchard Telephone Association, Inc., (Blanchard) informed the Commission of its intent to surrender its license. Blanchard states that it has transferred its telephone assets and business to Blanchard Telephone Co., a company that was licensed to provide basic local exchange service on June 26, 2007, in Case No. U-15226.

THEREFORE, IT IS ORDERED that:

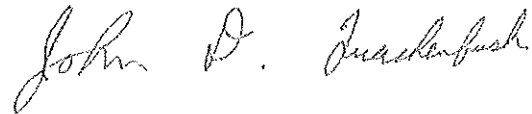
A. The license of Blanchard Telephone Association, Inc., to provide basic local exchange service is rescinded.

B. Blanchard Telephone Association, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so by the filing of a claim of appeal in the Michigan Court of Appeals within 30 days of the issuance of this order, under MCL 484.2203(12).

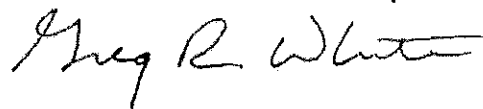

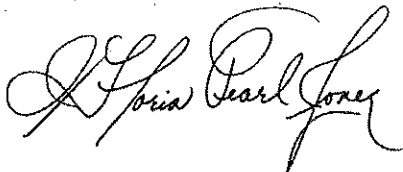
