ORDER

On December 7, 2000, Trans National Communications International, Inc., (Trans National) filed an application, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service. On March 29, 2001, the Commission granted the application. On October 8, 2014, Trans National informed the Commission of its intent to surrender the license. Trans National stated that all its assets were acquired by TNCI Operating Company LLC effective April 30, 2013. Trans National ceased all operations as of that date and has no customers in Michigan.

THEREFORE, IT IS ORDERED that:

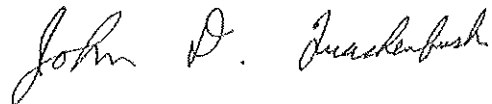
A. The license of Trans National Communications International, Inc., to provide basic local exchange service is rescinded.

B. Trans National Communications International, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so by the filing of a claim of appeal in the Michigan Court of Appeals within 30 days of the issuance of this order, under MCL 484.2203(12).

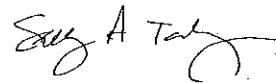

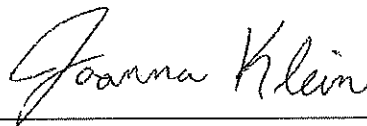
