The Michigan Public Service Commission (Commission) will hold a pre-hearing to consider DTE Gas Company's November 11, 2019 application requesting the Commission for authority to construct, operate, and maintain approximately 14 miles of 8-inch 2 diameter natural gas pipeline, the 8" Frankfort Loop Pipeline (Project), in Blair Township, Green Lake Township, and Inland Township, Grand Traverse County and Benzie County, Michigan and to find that the Project serves the public convenience and necessity and is safe for operation.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to: mpscedockets@michigan.gov. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by January 3, 2020. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon DTE Gas Company's attorney, David S. Maquera, One Energy Plaza, Detroit, MI 48226.

Any person wishing to appear at the hearing to make a statement of position without becoming a party to the case may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter becomes public information, thus available on the Michigan Public Service Commission's website, and subject to disclosure. Please do not include information you wish to remain private.

Requests for adjournment must be made pursuant to Michigan Office of Administrative Hearings and Rules R 792.10422 and R 792.10432. Requests for further information on adjournment should be directed to (517) 284-8130.
