On June 12, 2020, Winn Telephone Company, d/b/a Winn Telecom (Winn) filed an application with the Michigan Public Service Commission (Commission) for approval to expand its license to provide basic local exchange service. An amended application was filed on July 6, 2020, which clarified that Winn seeks to expand its service area to include all the zones and exchange areas in the State of Michigan for which it does not currently have a license.

Winn shall issue notice of its request by July 31, 2020.

Written and electronic comments may be filed with the Commission and be received no later than 5:00 p.m. on August 21, 2020. Written comments should be sent to the: Executive Secretary, Michigan Public Service Commission, P.O. Box 30221, Lansing, Michigan 48909. The notice shall indicate that all information submitted to the Commission in this matter will become public information, posted on the Commission's website, and subject to disclosure. Comments should not include information commenters wish to remain private.

Affidavits of issuance shall be filed with the Commission within 14 days of issuance.
